“We need to ensure older LGBTQ+ New Yorkers are connected to the resources and care they need to age with dignity. For many LGBTQ+ seniors, coming out decades ago may have meant losing their family, being evicted from their homes or fewer job opportunities. As a result, LGBTQ+ elders tend to be more isolated, have smaller support networks, and less financial stability than other seniors. I applaud SAGE and AARP for their comprehensive strategy to support older LGBTQ+ New Yorkers and will help them implement it however I can, including pushing for the passage of my legislation to establish an LGBTQ+ Long-Term Care Facility Residents’ Bill of Rights (S.85), to designate LGBTQ+ seniors and seniors living with HIV as a population of greatest social need (S.78), and to expand New York’s LGBTQ+ data collection practices (S.774).”
